(a) Ms.V.Ramya, Controller of Examinations presented the End Semester Examinations results – November 2019 of the autonomous batch. The analysis of results before and after revaluation of both UG and PG were recorded.

While discussing about the result analysis management representative, Prof.P.Vijayaraghavan, Secretary, College covering Council suggested that our faculty members should move away from conventional method and develop different patterns in consultation with Deans while preparing question papers even for the internal examinations like mid semester and model examinations. The Governing Body recorded and approved the same.

Principal Dr. V.Sujatha, expressed her concern towards the results of Arts departments and attributed the passing aggregate towards the decreased pass percentage in PG results which was recorded by the Governing Body.

To avoid the issues concerned with setting of questions out of the syllabus., University nominee, Dr.N.Thajuddin suggested to elaborate the topics unit wise while framing the syllabi rather than providing generalized topics and send the same to the question paper setters.

(b) Dr.V.Sinthu Janita Prakash , Vice-Principal and Member Secretary of the Academic Council presented the minutes of the second meeting of the Academic Council held on 12-12-2019 and the same were recorded.
